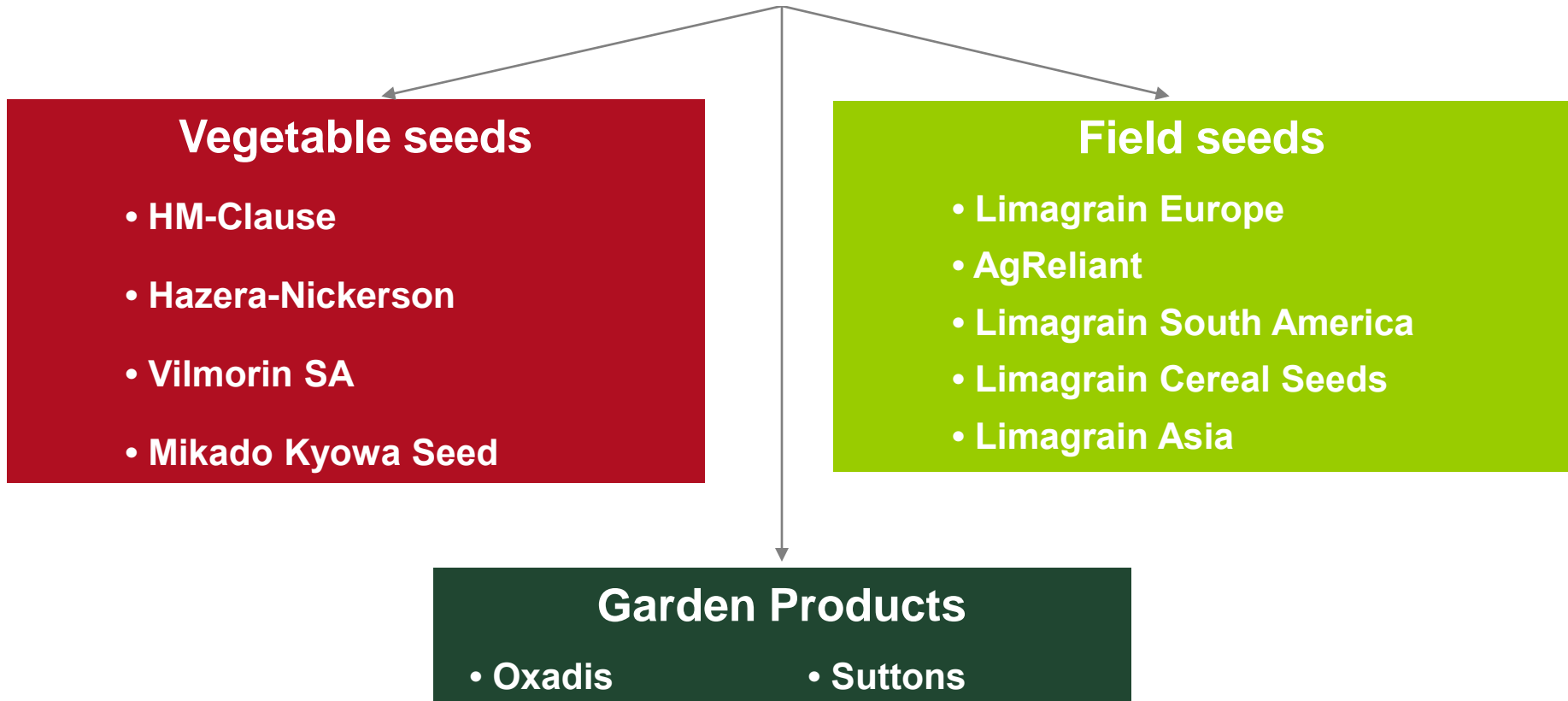

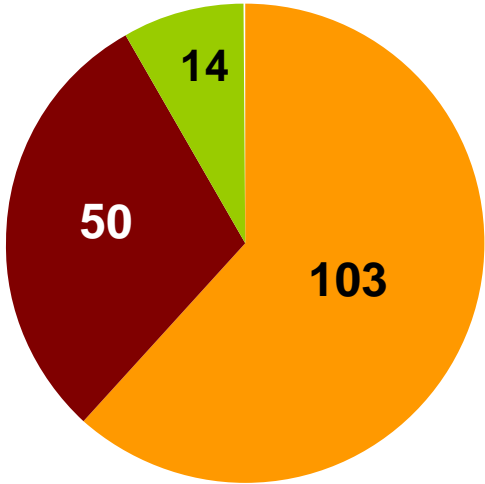
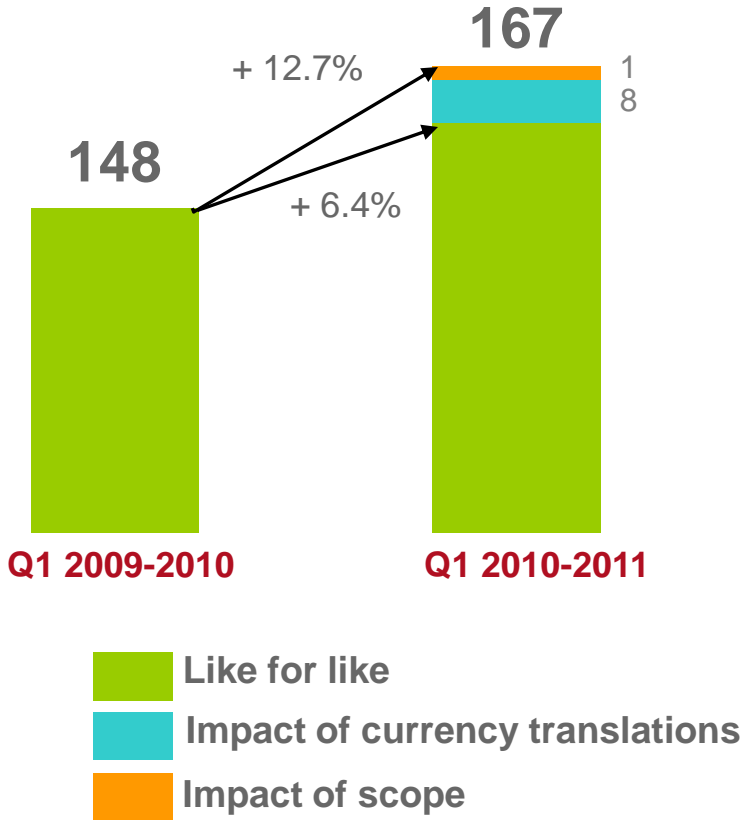

in €M

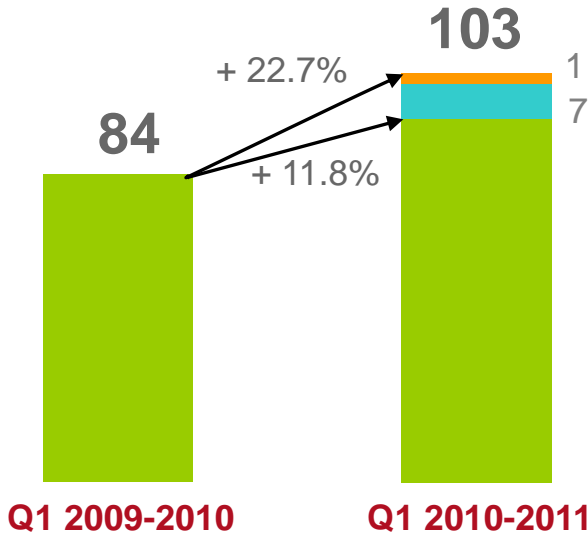

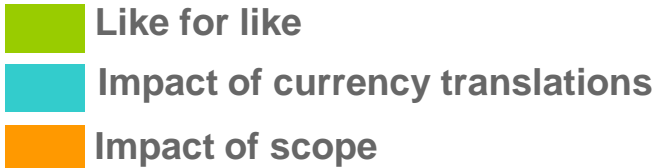

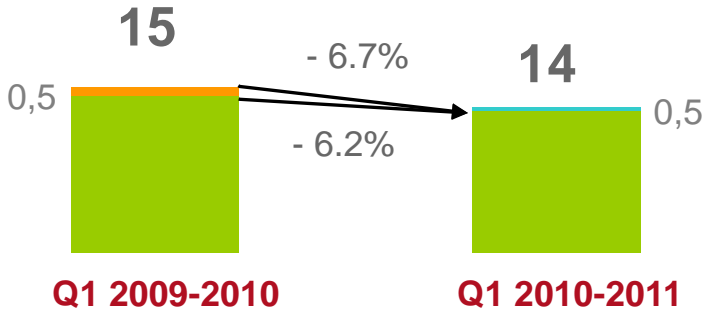

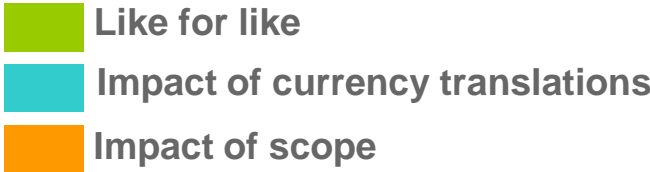

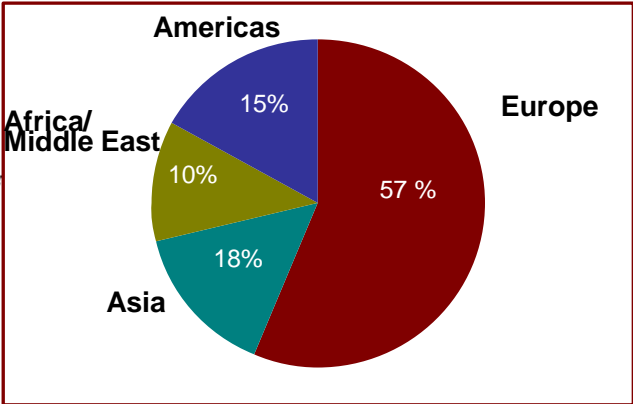

* Sales of goods: variation with current data compared to 2009-2010

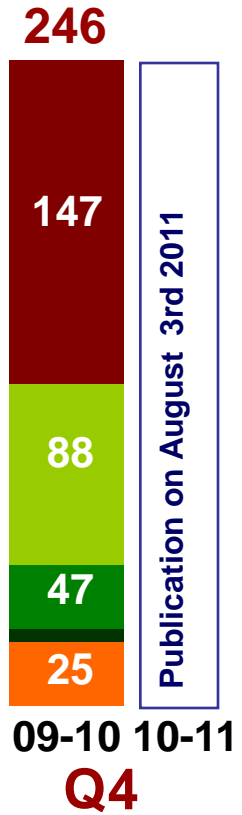
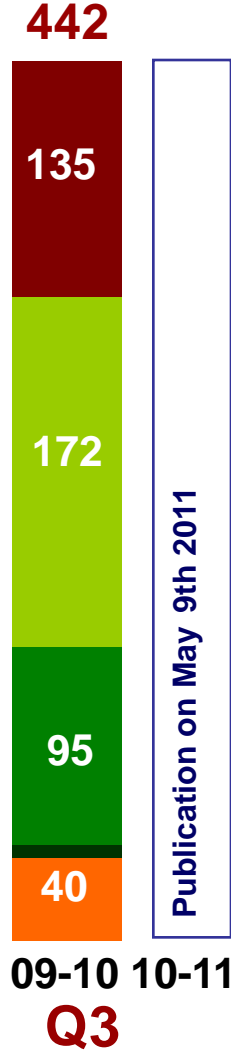
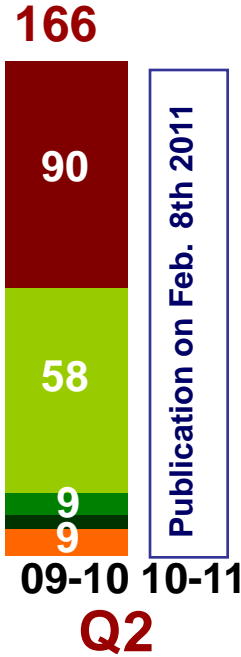
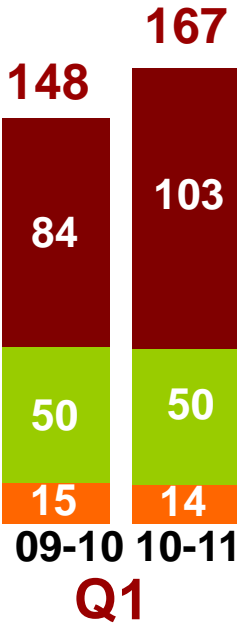
